# "Campaign 2010" Launched Fundraising Campaign Will Raise Money for Camp Improvements, Future Needs

October 15, 2007: When 4-H volunteers and county staff from Southwest Idaho organized the Cascade Lake 4-H Camp in 1965, they understood the importance of camping as a valuable learning experience for youth and wanted to guarantee that a place would always be available for youth to learn while experiencing the wonder of a natural environment.

Over the years, many improvements have been made to our fifty-six acres of pine forest on the shores of Cascade Lake Reservoir. Loans have been obtained, donations sought and volunteers recruited to build and maintain the camp's facilities and amenities.

In the last six years, the Camp Board has managed to find funds to build a new ADA restroom, update the lodge electrical, reseal the lodge floor, connect to county sewer, add a water filter, replace part of the docks, replace the kitchen appliances, replace the pump, and remodel the manager's cabin. These necessary improvements have depleted most of the camp's savings.

After 40 years of busy summer use, compounded by cold and snowy winters, there are still many

areas of the camp that are in need of upgrade and repair. Therefore the Camp Board is now in the process of seeking financial assistance for update projects to ensure that the camp can continue to operate in a safe and comfortable manner for many more years to come.

The Camp Board has recognized the need to put a new fundraising plan in place to fund current camp needs and build a reserve for future improvements. So this month we are launching a new fundraising campaign called "Campaign 2010." Our goal is to fund current camp improvements and to build a reserve to finish the projects with incomplete bids by the end of the year 2010. Our goal is to raise over \$200,000 in three years through a combination of grants, corporate support, and individual contributions.

The campaign's Leadership Team, comprised of Camp Board members and other volunteers, plans to target private foundations, Valley County businesses, Idaho corporations, former campers and counselors, 4-H alumni, volunteers, and parents. We have already received the donation of a much needed new milk dispenser. And a

former 4-H'er has personally pledged \$1000 to help kick-start the fundraising efforts.

The camp website has also been re-launched with a feature that allows people to make donations to the camp online. We will be asking current and former 4-H'ers to donate whatever they can, whether it is \$5 or \$500.

We encourage all of the 4-H clubs whose members have utilized the camp in the past to check out the new website and make whatever contribution you can - whether it is in the form of a financial contribution volunteering your time to help with camp improvements. The website also has the latest news about camp, registration forms, and you can even email a camper while they are at camp. Organizers of Campaign 2010 will be reaching out to clubs and individuals over the next year to discuss the project and encourage support.
